**ISSUE & BACKGROUND**

The City of Tualatin (the "City") has petitioned to annex that portion of the City lying within Clackamas County into the Library District of Clackamas County (the "District"). The City has met and negotiated proposed terms of its entry into the District with the District's advisory board. The proposed terms of the annexation are included in the resolution submitted by the City (attached). The next step in the process is for the Board, as the governing body of the District, to consider the petition of the City and either approve or disapprove of the petition. If the Board does approve the petition, a second hearing would be necessary to receive remonstrances, and then at a minimum an election would be required within the City regarding the proposed annexation.

**QUESTION(S) PRESENTED FOR CONSIDERATION**

Shall the Board approve the annexation of a portion of the City of Tualatin into the Library District?

**OPTIONS AVAILABLE**

The Board could tentatively approve the petition and hold a public hearing on the matter, tentatively scheduled for October 29, where a final determination would be reached.

The Board could tentatively disapprove the petition and hold a public hearing on the matter, tentatively scheduled for October 29, where a final determination would be reached.

The Board could request additional information for consideration of the petition.

**RECOMMENDATIONS**

Business and Community Services recommends the Board approve this petition for annexation and move forward with the consideration process.

Dear Commissioners,

On behalf of the City Council of the City of Tualatin, I am certifying and submitting to you Resolution No. 4908-09 that was adopted by the City Council on June 22, 2009. The Resolution proposes that the Clackamas County portion of the City of Tualatin be annexed into the Clackamas County Library Services District on the conditions stated in the Resolution.

The Council requests that you hear our proposal for annexation in time for it to be placed on the November 3, 2009 ballot. In consultation with your staff, we believe that if the County Board schedules the first Public Hearing by July 16, 2009, then has the First Annexation Hearing not later than July 30<sup>th</sup>, and the Second Annexation Hearing not later than August 6<sup>th</sup>, the annexation proposal can be submitted to the Clackamas County Elections Office in time for the November 3, 2009 election.
