The cover and signature sheets for the prospective petition filed by you for the Proposed City of Government Camp has been approved, allowing you to circulate for signatures. All signers must be active registered voters.

The identification number for the petition is 3-08-05. This number must be inserted on the line following the words "Petition I.D." in the upper right hand corner of the petition signature sheet (SEL 702) prior to copying and circulating for signatures.

Each signature sheet must be copied or printed back to back to the Petition for Incorporation (SEL 701).

Prior to circulation for signatures, please review the guidelines on the back of SEL 701 with circulators. Please note, once a circulator has signed and dated the circulator's certification on a signature sheet, no additional signatures may be collected on that sheet.

The number of valid signatures required for the formation of Government Camp is 14. We strongly recommend obtaining signatures of an additional 10 to 15 percent. Signatures are due no later than Dec. 24, 2008 by 5:00 p.m. (6 months after prospective petition has been filed) to proceed with the formation.




